Note: GRF appropriation item 763511, Local Disaster Assistance, in the Department of Public Safety, received appropriations of \$11.0 million in FY 2020 in the versions of H.B. 80 that were reported by the House Finance Committee and passed by the House. This item now appears in H.B. 166, the main operating appropriations bill, so it has been removed from this spreadsheet and added to the spreadsheet for H.B. 166. In H.B. 166, as passed by the Senate, the item also receives an appropriation of \$11.0 million in FY 2020.
